The abstract should be clear, concise and descriptive. Abstract is written in 12 pts Times New Roman (single spacing) and preferably no more than 300 words. Abstract should follow this format:

Background: brief background of the topic and significance of the study. **Purpose**: the major aim of the study. **Methods**: brief summary of study setting and participants; the study design; major methods used to collect and analyze data, including the proper name of instruments used. **Results**: the major findings. **Conclusion**: conclusions and implications for nursing practice. (Abstract must be written in one paragraph)

Maximum of 5 keywords separated by semicolon (;), crucial to the appropriate indexing of the papers, are to be given.

Structure of The Manuscript

Manuscript is written in 12 pts Times New Roman and single spacing.

BACKGROUND

Background provides the state of the art of the study and consists of an adequate background, the previous researches and significance of the study to show the scientific merit or novelties of the paper. Avoid the use of literature review or a summary of the results. It should be written as brief as possible, the statement mentioned in this section should be supported with the most current and important literature references. Author should state the research objective.

METHODS

An extensive description of method must be provided on how the study has been conducted. The method selection should be relevant with the research objective(s). Authors might use these subsections, if possible:

- **Design**: the type of study performed must be described, justified. Authors should explain a relevant reasoning toward design selection.
- **Place and time of research**: indicate the place and the time of performing the study. A relevant statement should be indicated.
- **Population and samples**: Specify the characteristics of the studied population and the inclusion and exclusion criteria. If all the population was not included in the study, author must indicate how the sample size was calculated and the value of each parameters, as well as the sampling technique.
- **Data measurement**: explain how the data have been collected and who did it along with the tools used. Author is responsible for the instrument validation.
- **Data analysis methods**: indicate the statistic test used for the analysis. Prisma tools can be used for the systematic literature review study.
- **Ethical aspects**: please provide sufficient details of the methods include ethical conduct.

RESULTS

Results describe the major findings of the study. It should be clear, concise and can be reported on texts or graphics. Please provide some introduction for the information presented on tables or images.

DISCUSSION

The discussion should explore the significance of the results of the study. The following components should be covered in discussion: How do your results relate to the original question or objectives outlined in the background section (what)? Do you provide interpretation scientifically for each of your results or findings presented (why)? Are your results consistent with what other investigators have reported (what else)? Or are there any differences?

CONCLUSION

Conclusion should answer the objectives of the study. Provide a clear scientific justification for your study, and indicate possible recommendation for nursing practice and future practice.

ACKNOWLEDGMENTS (if any):

Briefly acknowledge research funders, and any research participants in this section.

REFERENCES

Write reference in Havard format. The Reference consists of all references used to write the articles. Ensure that citations used are as contemporary as possible, including those from the current year of writing. It is advisable for the author to include the latest research finding with no more than 10 years, unless these are central to your study. References should avoid the use of secondary citations. Please use Reference Manager Applications like EndNote, Mendeley, Zotero, etc.




Figure 1. A sample chart/figure
